Mathematics Prerequisite: MAT 286 or MAT 296. Credit will not be given for both MAT 331 and MAT 485.

Textbook: Linear Algebra and its Applications, 5th edition, David C. Lay, Steven Lay and Judi McDonald

Course Description: Linear equations, Linear transformations, Matrices, *n*-dimensional Euclidean spaces, Associated geometry.

Calculator Policy: You are not allowed to use a graphing calculator such as TI-84, TI-85 on homework, quizzes, and exams in this class.

Homework: The key to success in this course is to master the homework. Problems from the textbook will be assigned at the end of each class. Although homework will not be collected, it is absolutely vital that you do the problems in order to learn the course material.

Quizzes: There will be a quiz on every Wednesday unless an exam is scheduled. There will be no make-up quizzes, but the two lowest quiz scores will be dropped.

Grading: Course grades will be based on quizzes (20%), two in-class exams (25% each), and a cumulative final exam (30%). The two in-class exams are tentatively scheduled for Sep. 30 and Nov 4. There will be no makeups for the in-class exams or the final exam. If you have a documented excused absence for one of the in-class exams, your grade on the relevant portion of the final will be used to cover the missed exam. The final exam will be given at the scheduled time which will be a 2-hour block between 8 am and 2:30 pm on Wednesday, Dec 16, 2015. There will be no exceptions, and so you should not plan to leave campus before 2:30 pm on Wednesday, Dec 16, 2015.

Attendance: You are expected to attend and participate in class. Missing class is the most common reason for poor performance in the course. If you must miss a class, you are responsible for obtaining notes for that class from a student who attended. It is also your responsibility to find out about any announcements made in class.
