## MAT 331: FIRST COURSE IN LINEAR ALGEBRA Section M002 (TuTh 8:00am – 9:20am)

**Textbook:** Linear Algebra and its Applications, 5<sup>th</sup> edition, by David C. Lay, Steven R. Lay, and Judi J. McDonald; Publisher, Addison-Wesley.

**Course Description:** linear equations, linear transformations, matrices, n-dimensional Euclidean spaces, associated geometry, and possibly a few optional topics. (Sections 1.1 - 1.5, 1.7 - 1.9, 2.1 - 2.3, 2.7 - 2.9, 3.1 - 3.3, 5.1 - 5.3 and 6.1 - 6.4 of the textbook are required. Other sections are optional.)

**Calculator Policy:** You are allowed to use a calculator (such as TI-84, TI- 85) on homework, quizzes, and exams for this class. Students must show work to receive full credit. The use of a symbolic calculator (such as the TI-89 or the TI-Nspire with CAS) is not allowed on quizzes or exams. There may be quizzes and specific exam questions that are designated no calculator.

**Homework:** With a few exceptions, homework will be assigned after each class and homework for the previous class will be collected at the beginning of each class. 20 homework will be collected and each is worth 3 points.

**Quiz:** With a few exceptions, there will be a quiz at the end of every Tuesday's class on the material covered in the previous week. There will be 10 quizzes and each is worth 4 points.

**Mid-term exam:** There will be 2 in-class mid-term exams: one on Tuesday, October 4<sup>th</sup> and the other on Thursday, November 10<sup>th</sup>. Each of them is worth 100 points.

**Final Exam:** The final exam will be given on Wednesday, December 14<sup>th</sup>, during a two-hour period between 8:00am and 2:30pm, and at no other time. Do not plan to leave the campus before 3pm on this day. The final exam is worth 100 points.

There will be no make-ups for homework, quizzes, and exams unless you have a truly exceptional excuse, which has to be corroborated by a statement from your doctor, coach, etc.

**Grading Policy:** Total points possible is 60 (homework) + 40 (quizzes) + 200 (mid-term exams) + 100 (final exam) = 400. A letter grade will be assigned based on the percentage of points that you earn:
