

The course is divided into three units. We start with eight to ten classes devoted to introducing and discussing open questions in graph theory - one question per class. Each of these classes will start with the basic definition and results needed to understand the open question. The rest of that class will be devoted to, as a class, working out simple examples and discussing possible methods of attack. Each student will select one of these open questions to research. The last third of the course will be devoted to reports by the students on the problem they selected. These first and third segments of the course will be separated by a development of the mathematical structure of fullerenes.
