**Prerequisite:** MAT 397 or graduate standing. A good understanding of calculus will be necessary to perform well in this course.

Goals: The course will introduce naive and measure theoretic probability. We will introduce real random variables and their, probability mass/density functions, cumulative distribution functions, means, variances and standard deviations, and general expectations. Joint and conditional distributions/expectations will also be considered. Limit theorems and their applications will be discussed.

Algebra of sets, Probability in finite sample spaces, Binomial and multinomial coefficients, random variables, expected values and standard deviations, density functions, and applications.
