Text: An Introduction to Analysis, by W.R. Wade, Prentice Hall, 4th edition.

Course Description: Introduction to the foundations of calculus covering topics from the following: the real number system, functions, limits, sequences, infinite series, continuity, and uniform continuity. Enrollment limited to mathematics majors. PREREQ: (MAT 375 OR CIS 375) AND MAT 397.

Course Content: Chapters 1-4: Real numbers, sequences, functions, differentiability. An approximate order of events is:

• Chapter 1 Some of this was covered in MAT 375. What is new is the real numbers as a complete ordered field (Sections 1.2 and 1.3). You are responsible for learning or recalling the rest of the material in Chapter 1.

• Chapter 2 Sequences, Bolzano-Weierstrass theorem, Cauchy sequences (Sections 2.1-2.4).

• Chapter 3 Limits of functions, Continuity, Uniform Continuity (Sections 3.1-3.4).

• **Chapter 4** Derivatives, Mean Value Theorem, Taylor's Theorem, L'hoptial's rule, Inverse function theorem (Sections 4.1-4.5).

Learning Goals:

·Understand the nature and role of deductive reasoning in mathematics.

·Use and understand the usage of mathematical notation.

·Follow proofs and other mathematical discourse.

·Write rigorous proofs of mathematical statements.

Course Grade: There will be two one-hour exams during the semester (each worth 25% of the course grade) and a cumulative final exam (worth 30% of the course grade). Also, there will be several equally-weighted problem sets which will be collected and graded. One homework score is dropped. Homework is worth 20% of the course grade. <u>Class attendance is required</u>.

Homework: There will be several problem sets assigned during the semester. You may work with others on the homework, but you must write up your own solutions and you are responsible for your solutions. <u>Homework is due at the beginning of class.</u> <u>Homework is not accepted late.</u>
