Learning Outcomes: The main goal of this course is to help you learn algebra you need to know to pass the Ph.D. preliminary exam in algebra. This course does not cover everything you need to know as the exam also covers material in MAT 632.

Text: Algebra by Michael Artin, Second Edition, Pearson, New York 2018.

Test dates: Tuesday, September 26, Thursday, October 26, Thursday, November 30. These tests will be during the regular class period.

Homework: Homework will be assigned during class. It will be due at the beginning of class the Thursday after it is assigned. It will be graded and will count toward the grade for the course. Students are allowed to collaborate on the homework, but each student must hand in her or his own separate assignments. Collaboration includes working on the problem together or giving hints to other students after you have solved it yourself. It does not include letting someone else simply copy your solution.

Final exam: Wednesday, December 13, 2017, 5:15 – 7:15 pm. It will be a comprehensive final exam.

Calculation of course grade: 3 tests during the term 20% each, homework 15%, final exam 25%.

The plan is to cover chapters 2, 3, 4 (sections 1-6), 6 (sections 7-10), 7 (sections 1-3, 6-8), 8 (sections 1-6).

All exams will be closed book, books, notes and calculators will not be allowed. Collaboration will not be allowed.
