<u>Course Description</u>: The course will discuss general procedures of estimation and hypothesis testing for linear models, especially simple and multiple regression models and analysis of variances models. The assumptions underlying the linear models of our interest and various methods of testing the validity of these assumptions will be considered. Also, applications will be discussed.
