2nd Course: Linear Algebra

Course Description: All or nearly all topics of the course are covered in Chapters 1, 2, 5, and 6 of the textbook. These topics are considered in MAT 331 from a computational viewpoint. (*MAT 331 is a prerequisite for this course, and the computational techniques in that course will be assumed for this course.*) Here they are reconsidered in a more abstract setting, with an emphasis on definitions, and proofs of Theorems. Specifically, the topics include abstract vector spaces and their subspaces, linear transformations and their matrix representations (Chapters 1, 2); eigenvalues and eigenvectors, inner product spaces (Chapters 5, 6). If time permits, some applications may be given.
