## MAT 284 – BUSINESS CALCULUS Summer 2017 Section 002 Session II

**Course Description:** This course covers one variable differential and integral calculus with applications to business and economics. MAT 284 may not be taken for credit after successful completion of MAT 285 or MAT 295 (4 credits).

Course Restrictions/Prerequisites: Although there are no formal prerequisites, the knowledge of Pre-Calculus material at the level of MAT 194 is essential for success in this course. Please note that the sequence of MAT 183-284, taken in either order, satisfies the Quantitative skills requirement of the Liberal Arts Core in the College of Arts and Sciences. However, this sequence is specially designed for students in the School of Management.

**Text:** "Introductory Mathematical Analysis" by Haeussler, Paul, and Wood, Custom edition for SU. Pearson, ISBN 9780558697129. Only the book is required. Used copies are fine. The course will cover most of chapters 1-4 and 10-14.

**Calculator:** A graphing calculator is required. The TI-84 or TI-83 calculator is the recommended graphing calculator for the course. Students who already own and know how to use another equivalent calculator (e.g. TI-85 or TI-86) are free to use it. Approved calculators will be allowed for class work, homework, tests, and quizzes. However, a calculator with symbolic calculus capability (such as the TI-89 or TI-92) is not allowed for exams and quizzes.

**Final Examination:** The final exam is comprehensive/cumulative and accounts for 25% of a student's overall grade in the course. The final exam will be given on Thursday, August 10<sup>th</sup> during the regular class period. Please do not plan to leave campus until after this date since this is the only time that the exam will be administered.

**Tests:** In addition to the final exam, there will be two midterm exams during the semester, each accounting for 25% of your final grade. There will be **no makeup tests**. However, for excused absences, the corresponding portion of the final exam will be used in place of the missing test score.

**Attendance Policy**: You are expected to be in class and participate every day (four days a week for the six weeks). Every day that you miss or do not participate, you will lose 5% of your total attendance score for the overall 10% category.

Homework and Quizzes: Homework problems from the textbook will be assigned at the end of each class.

Homework will not be collected, but it is ESSENTIAL that you know how to do the problems as there will be frequent quizzes based on the homework problems assigned. On July 5 and then every Tuesday, class will start with a quiz based on the homework assignments since the previous Tuesday. There will be approximately 5 quizzes throughout the term and there will be no makeup quizzes: the top 4 quiz scores will be averaged for that 15% of your grade.

**Grading:** The final score will be computed on a scale of 0 to 100 in the following way:

Attendance/Participation (10%), Quizzes (15%), Exam 1 (25%), Exam 2 (25%), Final Exam (25%).
